CONDITIONS OF LICENCE

- The person in whose favour this licence is issued shall. -
 - Comply with all the relevant provisions of the Act and Rules for the time being in force;
 - Not encourage or countenance any infringement of the provisions of the Act. or the Rules for the time being in force;
 - Exhibit this licence in some conspicuous part of the premises to which it relates;
 - Comply with any general or special directions that may be given by the Controller of legal metrology;
 - Surrender the licence in the event of closure of business and/or cancellation of Licence;
 - Submit the application for renewal of this licence as required under the rules within ninety days of expiry of the validity of the licence.
 - Not sell or offer, expose or possess for sale any non-standard weight or measure.
- Any change in the constitution of the firm should be reported to the license issuing authority within one month.
- Nothing in this rule shall confer on the licensee any assignable or transmissible right.

Explanation 1. The licensee shall not be deemed to have been assigned or transmitted within the meaning of this rule in the following cases, namely, where the licensee being an individual enters into a partnership with any other person for carrying on the business concerned; but in any such case the firm may use the license, if otherwise in force only for so long as the licensee is a member of the firm. Where the licensee being a firm subsequently undergoes a change in the constitution; but in any such case the reconstituted firm may use the license, if otherwise in force, only for so long as any partner of the original firm at the time of issuance of the license, continues to be partner of reconstituted firm.

Explanation 2. For the purpose of the explanation 1, "firm" has the same meaning as in the Indian Partnership Act 1932.
